Note 1: On March 17, 2020, the Governor issued Executive Order N-29-20 suspending certain provisions of the Ralph M. Brown Act in order to allow for local legislative bodies to conduct their meetings telephonically or by other electronic means. Pursuant to the Shelter-in-Place Order issued by the San Mateo County Health Officer on March 16, 2020, as revised on March 31, 2020, the statewide Shelter-in-Place Order issued by the Governor in Executive Order N-33-20 on March 19, 2020, and the CDC's social distancing guidelines which discourage large public gatherings, the April 15, 2020 Regular Meeting of the San Mateo County Board of Harbor Commissioners was conducted by video/teleconference.

11. <u>Charges for Services & Rent - COVID-19 Related Delinquencies (van Hoff)</u>

Discuss and consider waiving penalty and fees for delinquencies and allow twelve-month payment plans; alternatively consider full or partial rent forgiveness.

6:49 Commissioner Mattusch and Commissioner Larenas recused themselves from this item and exited the meeting.

Public Comments:

- Carl Hiltz Commented on deferral vs forgiveness doesn't think a deferral will solve the problem. He thinks forgiveness of any kind is the only solution.
- Sam Sigue He is a commercial fisherman and he relies on dock sales for all his income. Would like forgiveness of rent.
- Carolyn Gerin She rents a slip at Pillar Point Harbor, but it is vacant.
 Would like rent forgiveness.
- Patrick Donohoe He is a sport fisherman would like to know the status of the launch ramp.
- Bruce McPhillips Commodore of OPYC looking for a deferral of rent for everyone.
- Theodore Vecchione He is a fisherman at Pillar Point Harbor. His question was, "if you've already paid your rent how will rent forgiveness work"?
- Bob Ingles Owns Half Moon Bay Sportfishing would really like a deferral or rent forgiveness from the Harbor.

Motion: (Brennan) Waive all delinquencies, forgive and refund all rent and slip fees for the time period that the Harbor District has been closed. And forgo inflation increases CPI calculated for 2019. Extend launch ramp access by the number of months that the launch ramp is closed. Bring this item back later, in the event that we need to extend the time period of forgiveness and refund for rent and slips fees beyond the time period that the District is closed.

- 2) For non-essential businesses and essential businesses that remained closed: - waive requirement to find lessees and commercial activity permit holders in default due to delinquency of payments which occurred from the period of April 1-June 30, 2020 and allow for repayment of rents over a twelve-month period or by June 30, 2021.
- 3) For berthers (slip holders & mooring patrons):
 - waive requirement to lien vessels due to delinquent payments which occurred from the period of April 1-June 30, 2020 and allow for repayment of rents over a twelve-month period or by June 30, 2021.
- 4) For essential business that remained open:
 - waive requirement to terminate leases and commercial activity permits due to delinquent payments which occurred from the period of April 1-June 30, 2020 and allow for repayment of rents over a twelve-month period or by June 30, 2021.
- 5) Approve the Rates and Fees Schedules as currently published and forgo the 3.3% inflation increase calculated for 2019. Add the 3.3% inflation increase to the 2020 calendar year increase to determine the two-year inflationary increase to be implemented on July 1, 2021. This calculation shall not reduce rates.
- 6) Defer lease terms associated with requirement to increase rents by the consumer price index (CPI) for one year and add to the 2020 CPI to determine the two-year inflationary increase. This calculation shall not reduce base rents.
- 7) Extend annual launch ramp permits by the number of months that the launch ramp is closed.
