Timeline for West Trail Project

- **September 7, 2016 Board approves west trail GHD alternative analysis:** shotcrete wall with possible sand replenishment.
Unanimous
- **September 20, 2017 Board approves shotcrete wall.** Bernardo, Mattuch, Kiraly yes, Brennan, Larenas no.
- **October 2017 Coastal commission denies the project** after Larenas and Brennan ask the commission for a living shoreline assessment.
- **2018 The living shoreline west trail project unanimously approved.**


Continuing the false narrative...

Details on timeline

September 7, 2016 Board approves west trail GHD alternative analysis: shotcrete wall with possible sand replenishment.

Surfrider Foundation Chair Edmundo Larenas states that Surfrider will not support rock armoring and may support shotcrete combined with sand replenishment.

September 20, 2017 Board approves shotcrete wall. Bernardo, Mattuch, Kiraly yes, Brennan, Larenas no.

Coastal commission denies the project

- October 2017 Larenas and Brennan ask Coastal Commission staff for help, explaining that the district did not evaluate contemporary shoreline protection methods such as living shoreline. The **Coastal Commission agreed and denied the project.**
- **2018 The living shoreline west trail project unanimously approved.**
- **July 24, 2020 Boad approves the Budget** with a 3 to 2 vote Larenas and Brennan voted not to approve because they would not support a budget that did not include Renovation of Johnson Pier among other reasons.
